Background

As of the 25th October 2022, there have been 625,740,449 confirmed cases of COVID-19 and 6,563,667 deaths globally. In Afghanistan, there have been 202,240 confirmed cases of COVID-19 with 7,819 deaths reported through WHO dashboard. As the COVID-19 pandemic is an ongoing pandemic, new sub-variants may cause a dramatic surge in COVID-19 cases, there is a need to sustain COVID-19 services ensure essential preparation and response to a possible surge.

During the pandemic, COVID-19 hospitals were supported and managed by HNTPO to respond to the large influx of patients and manage virus transmission. The WHO has planned to reshape these COVID-19 hospitals into infectious disease hospitals, expanding their response capacity to cover the priority infectious disease outbreaks and epidemics, including COVID-19, measles, acute watery disease (AWD)/cholera and dengue fever.

Objectives

Protect the population of Afghanistan and reduce the prevalence and spread of infectious diseases including COVID-19, measles, AWD/cholera and Dengue Fever. The project will ensure the resilience of Afghanistan's hospital healthcare to combat outbreaks and epidemics of infectious diseases. The project will:

- Maintain hospital services for patients of COVID-19/SARS, respond and mitigate the threat posed by COVID-19 in Afghanistan;
- Strengthen national health systems preparedness and capacity to respond to public health emergencies;

COVID-19 facilities and infectious disease hospitals include:

- The Afghan Japan Infectious Disease Hospital in Kabul.
 - The COVID-19 department will function in capacity of 60 beds, which will serve critical cases received from all the hospitals in Kabul and surrounding provinces.
- 1 regional hospital in Nangarhar with a capacity of 581 beds including 32 for infectious diseases.
- Fatema-tu-Zahra primary health centre in Nanagarhar with 120 beds and 12 allocated for infectious diseases.
- University teaching hospital with 120 beds and 8 allocated for infectious diseases.

Activities

- Manage and isolate COVID-19 suspected and confirmed cases with enhanced management and isolation of severe cases;
- Improve prevention of COVID-19 and infectious diseases through risk communication and promotion of healthy behaviours;

- Ensure regular supply of oxygen, medicines and other materials to the COVID-19 department at infectious disease hospitals in Kabul and Nangarhar;
- To ensure infection prevention and control measures at all health facilities;
- Carry out training to enhance capacity of healthcare providers;
- Facility Management of Afghan Japan Hospital;
- Supervision, Monitoring, Reporting, and Data Management.

Past Projects

Since the start of the pandemic, HNTPO has ensured the provision of testing, vaccination and treatment for patients of COVID-19. In 2021, HNTPO coordinated and managed COVID-19 hospitals including the Afghan Japan Hospital, one of only five hospitals offering treatment for COVID-19 in the country and the only COVID-19 hospital in Kabul.

In 2022, we established two COVID-19 hospitals and a rapid response team to provide COVID-19 response services, including community surveillance, treatment and psychosocial counselling. Mobile health teams travelled to remote and hard-to-reach communities raising awareness and offering preventive support, referrals and psychosocial support. We also improved clinical staff capacity and led to 197,843 COVID-19 vaccinations and 56,142 people reached through our interventions.
